| Position Description:        | Under attorney supervision, an intern for detention programs will participate in the preparation of applications for Cancellation of Removal, Adjustment of Status, Asylum, Withholding of Removal or Convention Against Torture protections (including evidence gathering, briefing, affidavit writing, and document preparation). The purpose of this position is to better understand how to ensure access to justice for vulnerable immigrants in detention. Interns work closely with the detention team to evaluate potential forms of relief available to <i>pro se</i> detainees for direct representation by PIRC or for <i>pro bono</i> referrals. Interns will also conduct intakes for those detained by DHS and respond to requests for legal assistance. |
